Extended Producer Responsibility (EPR)

EPR policies require manufacturers to take responsibility for the entire lifecycle of their products, particularly their environmental impact. These policies are designed to promote recycling, reduce waste, and encourage product design changes that minimize environmental harm.

EPR vs. CSR: What's the Difference?

Extended Producer Responsibility (EPR) is a mandatory regulatory framework that requires manufacturers to manage the entire lifecycle of their products, including waste collection, recycling, and disposal. It enforces compliance through laws and financial obligations.

Corporate Social Responsibility (CSR) is a voluntary business strategy focused on ethical, environmental, and social impact. Companies adopt CSR to enhance their brand, improve sustainability, and engage stakeholders beyond legal requirements. While EPR ensures compliance, CSR builds reputation—together, they create a stronger, more sustainable business model.





Current Legislation:

European Union

- <u>EPR Textile Proposal (July 2023)</u>: Part of the broader EU efforts under the European Green Deal and Circular Economy Action Plan, this proposal makes textile producers responsible for circular design and significant waste reduction.
- March 14, 2024, Legislation Update: The European Parliament voted in favor of revising the Waste Framework Directive, requiring clothing and footwear manufacturers to cover the costs of collecting, transporting, and sorting products for reuse or recycling.

France

- French Circular Economy Law (February 2020)

Netherlands

• <u>Dutch EPR Decree (July 2023)</u>: Implements EPR policies specific to the Netherlands, ensuring environmental responsibility throughout the product lifecycle.

United States

 EPR policies in the U.S. are primarily enacted at the state level, with active legislation in key states such as California, Colorado, Maine, Minnesota, and Oregon.

California

SB 707 - Responsible Textile Recovery Act of 2024:

- Requires brands to contribute to an EPR program managed by Producer Responsibility Organizations (PROs), which facilitate recycling programs in partnership with CalRecycle.
- PRO Membership: Companies must join a PRO, which will oversee the collection, sorting, and recycling of textile products.

Timeline:

- January 1, 2026 PRO application due.
- January 1, 2031 Full program implementation.
