### Omnibus Simplification Proposal Compliance



#### **Omnibus Simplification:**

The Omnibus Simplification Package, introduced by the European Commission, is aimed at reducing administrative burdens for businesses while maintaining sustainability and compliance goals. The package is expected to save approximately  $\in$ 6.3 billion in annual administrative costs and unlock an estimated  $\in$ 50 billion in public and private investment capacity.

The reforms streamline several key regulatory frameworks, including the Corporate Sustainability Reporting Directive (CSRD), the Corporate Sustainability Due Diligence Directive (CSDDD), and the EU Taxonomy.

#### CSRD (Corporate Sustainability Reporting Directive)

Element	Before OSP	OSP Proposal
Company Scope	Companies with 250+ employeesand €50M turnover	Only companies with >1,000 employees and either €50M turnover or €25M balance sheet total remain in scope
Number of Companies Covered	>50,000 companies required to report	<7,000 companies required to report
Foreign Companies with EU Revenue	Non-EU companies with €150M EU turnover had to comply	The threshold raised to €450M EU turnover
Supply Partner Reporting	Companies had to collect data from all suppliers	No longer required to obtain data from non-CSRD suppliers
Sector-Specific Reporting	Mandatory sector- specific standards (ESRS) were to be introduced	Sector-specific reporting is scrapped
Reporting Deadlines	Set deadlines for first disclosuresand audits	Reporting delayed by up to two years, with some companies starting in 2028

### CSDDD (Corporate Sustainability Due Diligence Directive)

Element	Before OSP	OSP Proposal
Scope	Covered entire supply chain	Now applies only to direct suppliers, unless major risks are identified
Supplier Monitoring	Annual due diligence required	Reduced to once every five years
Supplier Risk Assessment	Included indirect suppliers in risk evaluations	Only direct suppliers are assessed unless plausible risk exists
Supplier Contract Termination	Companies had to terminate contracts with non-compliant suppliers	No longer required to terminate contracts
Legal Accountability	Companies could face civil liability for non-compliance	Civil liability removed
Transition Plans	Companies had to implement transition plans for sustainability	Companies only need to adopt transition plans, not enforce them
Penalties	Maximum fines not less than 5% of global turnover	Penalty provisions removed
